Kinsey, filed this action in the district court for Otoe County seeking to quiet title to and partition a farm jointly owned by him and his father, appellees Frank O. Kinsey and James R. Kinsey, each of whom had been twice married. Appellees, children of each of their two prior marriages, filed separate answers and cross-petitions wherein they denied appellant's ownership of the property and alleged a right to be the sole owners thereof, and further denied appellant's right to partition. Thereafter appellees filed motions for summary judgments and for dismissal, alleging the entire action was moot. Appellant also filed motions for summary judgment and dismissal. On the hearing the trial court sustained appellees' motion, entered summary judgments dismissing the entire action,

and overruled appellant's motions. Appellant's motion for new trial was overruled. Appellant's motion for new trial sets out in substance that there is no evidence to sustain the summary judgments, that there is evidence of the truth of the allegations therein, that the trial court failed to give consideration to appellant's constitutional right of trial by jury, and that in making the summary judgments the trial court misinterpreted and misapplied the laws of partition, equity, and other law applicable to the issues. Appellant's assignments of error are predicated upon his contention that his cause of action was not moot, and that the trial court in dismissing the same wrongfully ignored and misinterpreted his constitutional right of trial by jury. We find no merit in any such contention. Appellant in the trial court filed a motion to
